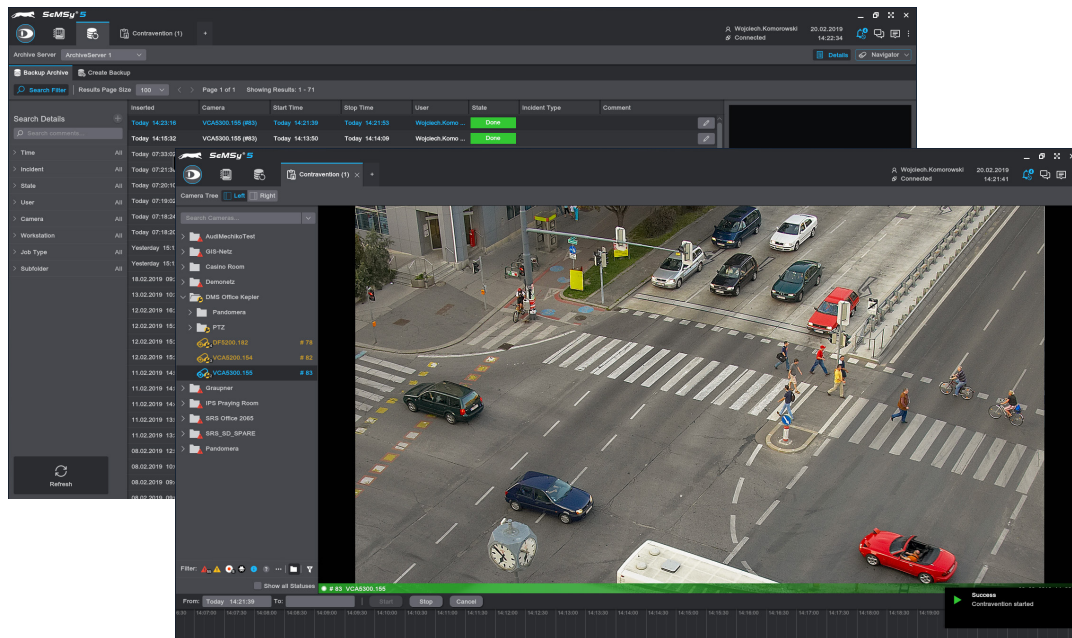


# SeMSy® Contraventions Process

HEMISPHERE® SeMSy® Contraventions Process for fast backup and archiving of live observed incidents / contraventions on a HEMISPHERE® SeMSy® Workstation



The HEMISPHERE® SeMSy® Video Management System combines the proven concept of its predecessors with new dynamics and flexibility. The optimized license model with administration on the central HEMISPHERE® Backbone Server allows a simple, fast and secure adaptation and expansion of the entire system during operation.



## Function

The HEMISPHERE® SeMSy® Contraventions Process is used to quickly and easily secure recordings of incidents or contraventions that are observed live. The app supports operators on a SeMSy® workstation in monitoring and evaluating a camera live stream with a special function set.

## Fast Recording

If an operator observes an incident / contravention live, he can immediately start recording the camera live stream. For this purpose, the app has a functional control center on a timeline for starting, stopping and aborting recordings.

## Automatic Backup

After a recording is stopped again, it is automatically backed up. This is done in the background without the operator having to switch to the corresponding HEMISPHERE® SeMSy® Backup Application. The backup is saved with time stamp, camera name and the name of the operator in the archive.

## Cancelation Only with Reason

Once a recording of an incident has been started, it can be canceled again without a backup being made. However, it is necessary that the operator causes the abortion. The operator selects an abort option from an automatically displayed drop-down list of prefabricated reasons. In addition, certain reasons may require manual text entry in a comment field. Depending on the requirements of a system, selection options with subsequent text input fields can be configured individually.

## Logbook

All user actions – start/stop/backup creation – are fully logged in the HEMISPHERE® SeMSy® Logbook Application. Also, recording cancelations together with their reasons are noted there.

## Application

The HEMISPHERE® SeMSy® Contraventions Process was designed for the monitoring of parking areas and public areas, for example, in which operators systematically evaluate specific contraventions live and secure evidence of them.
